40 Hour Divorce Mediation Training

Divorce mediation is rapidly becoming the preferred method for couples to get divorced. If you are an attorney, mental health or other professional and want to become a divorce mediator and receive training from New Jersey's premier association of professional mediators, you should take this course.

Program Features

- Multi-disciplinary faculty: The faculty is composed of attorneys, mental health professionals, CPA's and other professionals who mediate divorces regularly.

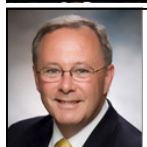
